Hybrid Meeting/Housekeeping Slides: CPCCO staff presented slides

**CODA Presentation:** CODA staff updated the CAC on the Seaside program. They currently provide walkin medication and substance use treatment services for any individuals with moderate to severe **opioid** use. They do not need to live in the geographic area. CODA will dispense courtesy doses. The nursing staff dispense medications M-TH 5:30 am – Noon on site. The average visit lasts 2 hours. They have the capacity for 300 patients and currently are serving 107 (60 patients per day). It is considered low-barrier access because they do not require a counseling component to receive services. They are piloting the Sonora App in Clatsop County, which will be a web-based platform for taking medications at home and will connect the clinician and patient. The program is currently looking for ways to develop community partners to help change the perception of recovery programs and participants.
